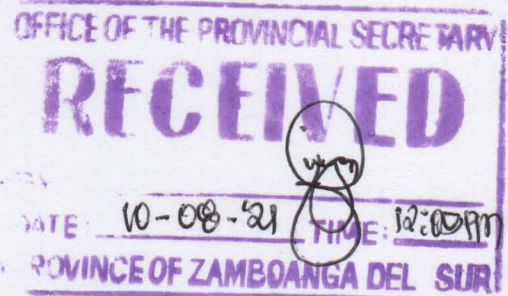

MUNICIPAL ORDINANCE NO. 06-2021

AN ORDINANCE ESTABLISHING THE MUNICIPAL DENGUE BRIGADE (MDB), DEFINING ITS POWERS AND DUTIES, PROVIDING PENALTIES FOR VIOLATION THEREOF.

BE IT ENACTED, AS IT IS HEREBY ENACTED by the Sangguniang Bayan of Ramon Magsaysay, Zamboanga del Sur in session assembled:

Section 1. Title. – This Ordinance shall be known as the , “An Ordinance Establishing the Municipal Dengue Brigade (MDB), Defining Its Powers and Duties, Providing Penalties for Violation Thereof.”

Section2. Definition of Terms. – As used in this Ordinance, the terms below shall have the meanings, to wit:

- Dengue Infection – is a mosquito-borne viral disease that is transmitted by female mosquitoes mainly of the species *Aedes Aegypti*. This infection can cause flu-like illness, and occasionally develops into a potentially lethal complication called severe dengue.
- Aedes Aegypti* Mosquito – the principal mosquito vector of dengue viruses is an insect closely associated with humans and their dwellings.
- Consultation – is a meeting with an expert or professional, such as a medical doctor, in order to seek advice.
- Fogging – to treat with something, especially an insecticide, in the form of a spray.

Section 3. Strategy and Monitoring to Eliminate Dengue Crisis

- Use the 4 S strategy:
 - Search and Destroy
 - Seek Early Consultation
 - Self-Protection
 - Say No to Indiscriminate Fogging
- Encourage and compel barangay health workers in cooperation with the Municipal Health Office to submit their monthly report to the Integrated Provincial Health Office for consolidation and monitoring for appropriate interventions and control measures against Dengue.

Section 4. Schedule of Regular Clean-up

- There shall be a programmed massive clean-up of each purok of every barangay every Friday at 3:00-5:00 PM, whole year round.

b. There shall be a programmed massive clean-p for business entities and offices located within the municipality every Monday at 8:30-9:00 AM, whole year round.

Section 5. Calendar of Activities for Monitoring Team

- a. 1st week of Implementation – massive Information dissemination of the activation of the Dengue Brigade
- b. 2nd week of implementation – house to house, school, office, establishment and barangay visitation and inspection.
- c. 3rd week of implementation – sending of notices to households, schools, offices, and barangays that has deficiencies in the implementation of this Ordinance.
- d. 4th week of implementation – sanctioning of households, schools, offices and barangay that did not improve on their deficiencies.


Section 6. Penalty – There shall be a penalty of One Thousand Pesos (Php 1,000.00) for violation of any of the provisions of the preceding sections of this Ordinance.

Section 7. Separability Clause – Any provision of this ordinance which may be declared later as illegal or unconstitutional shall not make this ordinance invalid or unconstitutional.


Section 8. Repealing Clause – All ordinances contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 9. Effectivity Clause – This ordinance shall take effect upon its approval.
