MUNICIPAL ORDINANCE NO. 07-2020

AN ORDINANCE CREATING THE POSITION OF MIDWIFE III IN THE MUNICIPAL HEALTH OFFICE, MUNICIPALITY OF RAMON MAGSAYSAY, ZAMBOANGA DEL SUR.

BE IT ORDAINED by the Sangguniang Bayan of Ramon Magsaysay, Zamboanga del Sur, in session assembled:

Section 1. Creation. This following item in the Municipal Health Office is hereby created:

1.1 Item 103 for the position of Midwife III with Salary Grade 11

Section 2. Powers, Duties and Obligations. The Municipal Health Officer shall determine the functions and responsibilities of the above-stated created position in accordance with the civil service rules and regulations.

Section 3. Compensation. The Midwife III shall receive a monthly salary equivalent to Salary Grade 11 and such other allowances and emoluments as may be allowed by existing laws and circulars, which may thereafter be included in the municipal annual budget.

Section 4. Qualification. The qualification for the said position shall be based on the standards set for by the Civil Service Commission.

Section 5. Funding Requirement. The funding of the created position shall comply with existing budgetary rules and regulations.

Section 6. Plantilla of Personnel/Personnel Schedule. The Human Resources Management Officer is hereby task to include in the Plantilla of Personnel/Personnel Schedule of the Municipal Health Office the position/item created under Section1 hereof.

Section 7. Separability Clause. If, for any reason/reasons, any part or provision of this Ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

Section 8. Repealing Clause. All ordinances, local issuances or rules inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 9. Effectivity. This Ordinance shall be effective upon approval thereof.
