## **MUNICIPAL ORDINANCE NO. 11-05-2023**

"AN ORDINANCE ADOPTING THE GUIDELINES PROVIDED IN THE SOCIAL HANDBOOK FOR THE FORMULATION OF THE SOCIAL PROTECTION PROGRAM AND THE CREATION OF THE SOCIAL PROTECTION TEAM AND ITS SOCIAL FUNCTION AND ADOPTION OF FAMILY RISK AND VULNERABILITY ASSESSMENT MANUAL."

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF RAMON MAGSAYSAY, ZAMBOANGA DEL SUR IN SESSION DULY ASSEMBLED, THAT

**SECTION 1. TITLE** – This Ordinance shall be known as the "An Ordinance Adopting the Guidelines Provided in the Social Handbook for the Formulation of the Protection Program and the Creation of the Social Protection Team and its Social Functions."

SECTION II – THE OBJECTIVES OF THE SOCIAL PROTECTION PROGRAM OF THE MUNICIPALITY OF RAMON MAGSAYSAY – Social Protection Programs primarily aims to improve the quality of life of the poor and the vulnerable. Specifically, the objectives of the SPP are four-fold.

- To protect and prevent people from falling from their current income or consumption levels due to various risks;
- To build people's capacity and adaptability so that better quality of life is maintained and sustained;
- 3. To expand income opportunities and improve human capital investments in the long term;
- 4. To sustain one's standard of living in spite of people's exposure to various natural and man-made risks;
- 5. To identify the risk and vulnerabilities encountered by individuals, families and communities through the preparation of the SPDR;
- 6. To provide the Fos and the local social welfare and development offices a tool in identifying risk and vulnerabilities for the SPDR;
- 7. To guide the Fos and the local social welfare and development offices in undertaking risk-response gap analysis in relation to assessment of the poverty situation in the area; and
- 8. To serve as useful reference in integrating social welfare and development (SWD)/social protection concerns in the regional and local development planning.

SECTION III. CREATION AND COMPOSITION OF THE MUNICIPAL SOCIAL PROTECTION TEAM – The Municipal SP team will be the Municipality's main advocates for social protection. The Municipal SP team shall be composed of:

**SECTION IV. FUNCTIONS OF THE MUNICIPAL SOCIAL PROTECTION TEAM** – The Municipal SP team will do multiple roles, specifically:

- a. It will conduct the risk and vulnerability analysis;
- b. After RVA had fleshed out the SP needs of the residents, the team will plan, mobilize resources, implement and monitor and evaluate the outcomes of SPP.
- c. The team can even complement to the roles of the Municipal Planning and Development Council and Municipal Disaster Risk Reduction and Management Council.

**SECTION V. REPEALING CLAUSE** – Any existing ordinance inconsistent herewith is hereby repealed and amended.

**SECTION VI. SEPARABILITY CLAUSE** – If any part of this ordinance shall be declared by the Court as null and void, the other portions hereof shall remain valid and legal in full effect.

SECTION VII. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval.
