**MUNICIPAL ORDINANCE NO. 6 – 2017**

**“AN ORDINANCE ORDAINING A TOTAL BAN OF THE USE OF FIRECRACKERS AND OTHER FORMS OF EXPLOSIVES DURING CHRISTMAS SEASON IN THE MUNICIPALITY OF RAMON MAGSAYSAY, ZAMBOANGA DEL SUR AND PROVIDING PENALTIES FOR ANY VIOLATION THEREOF.”**

**WHEREAS**, one of the most common festive way of celebrating the yuletide season is the use of firecrackers and other forms of explosives like Atomic big, Super Lolo, Trianggulo, Giant Whistle Bomb and other types of its equivalent which is still uncontrolled despite of its prohibition;

**WHEREAS**, the continuous usage of these materials not only cause disturbance and fear among small children and peace-loving citizens in the community due to its noise but also the damaging effects of its explosive content to one's health as well;

**NOW, THEREFORE**, be it ordained by the Sangguniang Bayan of Ramon Magsaysay, Zamboanga del Sur in session assembled that:

**SECTION 1. TITLE.** This Ordinance shall be called, “An Ordinance Ordaining a Total Ban on the Use of Firecrackers and Other Forms of Explosives during Christmas season in the Municipality of Ramon Magsaysay, Zamboanga del Sur and Providing Penalties for any Violation Thereof.”

**SECTION 2. REGULATORY/PROHIBITIVE PROVISION.** No person or persons shall be allowed to use firecrackers and other forms of explosives like Atomic big, Super Lolo, Trianggulo, Giant Whistle Bomb, and the like during Christmas or yuletide season specifically from November 18 to January 6 of the succeeding year.

**SECTION 3. PENAL PROVISION.** Any person or persons found violating the provisions of this ordinance shall be fined in the amount of Five Hundred (Php500.00) Pesos for the first offense, One Thousand (Php1,000.00) Pesos for the 2<sup>nd</sup> offense, and Two Thousand (Php2,000.00) Pesos for the 3<sup>rd</sup> and succeeding violations and imprisonment of thirty (30) days or one month to six months upon the discretion of the competent court.

**SECTION 4. AMENDATORY CLAUSE.** All existing laws, ordinances, resolutions, and executive orders found in conflict with this ordinance shall be deemed and considered modified and amended accordingly.

**SECTION 5. EFFECTIVITY CLAUSE.** This Ordinance shall take effect immediately after fifteen (15) days following the completion of its posting in three (3) conspicuous public places in the Local Government of Ramon Magsaysay, Zamboanga del Sur.
